Treasurer's report

\$21,373.16 as of todayPaid Solitude \$20,900 for herbicide treatment (pending reimbursement from state)Aqualogic has not yet billed us but cost will be about \$12,000

Budget review

Committed:

- Sanbornton \$5,000 pending (Terry to go to Town Hall on 9/17)
- Belmont: will reimburse after diver/DASH work complete
- Tilton: Tom to submit request for diver work
- Laconia: payment received
- Meredith: payment received

Milfoil Program status

- Herbicide treatment was conducted by SOLituded 8/21
- Check on whether SOLitude needs to do any followup testing. (Lisa)
- Procellacor is very effective although a second round may be required in some areas.
- Aqualogic update:
 - Billing: 12.7 hrs/90 gals to Meredith; 1.0 hr/0 gals to Laconia; 1.0 hr/5 gals to Sanbornton; 19.8 hrs/170 gals to Belmont; 19.0 hrs/290 gals to Tilton
 - Total Harvested: 465 Gallons
 - Total Hours: 52 hrs, 30 mins (8 ³/₄ days)
 - DASH completed on Belmont Canal / 1 pond with 1 pond (the worst) remaining
- Do not want to exceed budget allocation. Will be keeping tabs with one day to perform cleanup as needed.
- Tilton to be assessed next year for herbicidal treatment (per Amy). Milfoil was embedded in the rocks (across street by Shalimar) and difficult for divers to get it all. Note: should have a direct impact on Silver Lake as well which has been a topic of discussion with Tilton ConCom.
- May need to reach out to a member next year for boat docking overnight in the vicinity of the work.
- Press releases have not been published as of yet. Ed to check on this.
- Aqualogic wrapping up this week.
- Final bills forthcoming.

Water Quality Monitoring

- Final round of lake samples taken and submitted for assessment
- Judy & Dean will conduct another round of tributary monitoring in the next several weeks

Watershed Management Planning Updates

- LRPC, partnering with WWN, submitted letter of intent for grant funding under section 602B for development of a Watershed Mgmt Plan (\$40k). The majority to go to an environmental consultant to perform the assessment per EPA mandated guidelines to include pollutant loading (likely phosphorous). The total budget for a WMP is ~\$75k so that the remaining budget will need to come from other sources. Some could possibly come from the Pardoe Foundation. Volunteers will also be needed as well (LisaE, Dean & possibly Bob)
- LRPC had to apply for it in partnership with WWN.
- We should hear back within the next few months.
- Timeline for the project is about a year.
